FIRST YEAR ACTION PLAN NOTICE 2015

1. Introduction

The proposed 2015-2019 Consolidated Plan and 2015 Action Plan for Franklin Township has been prepared as required by the U. S. Department of Housing and Urban development (HUD). At this time, the Township participates in the Community Development Block grant (CDBG) program and the Somerset County HOME Consortium. Regulations require the preparation and submission of a Consolidated Plan/Annual Action Plan (The Plan) which is available at the Grants Office, Franklin Township Municipal Building, and 475 DeMott Lane, Somerset during regular business hours. A copy of the Plan will also be available for review at the Franklin Township Public Library, 485 DeMott Lane; the Township Clerk's Office and posted on the Franklin Township website www.franklintwp.org. The Consolidated Plan outlines the housing and community development needs of the Township and resources available to meet those needs for the next five years 2015-2019. The Action Plan establishes a one year plan that outlines the specific use of resources. Citizens have 30 days to review the document and submit comments from May 21, 2015.

Citizens who wish to express their views on the Plan can do so by sending comments to the Office of Grants at the Franklin Township Municipal Building or through the e-mail address of deborah.mitchell@twp.franklin.nj.us. All citizen comments will be considered in preparing the final Plan. A summary of these comments or views, and a summary of any comments or views not accepted and the reasons therefore, will be attached to the final Action plan. Information on the past use of funds, the amount of funds in the proposed program to be used for activities benefiting low and moderate-income persons is also available in the Office of Grants during regular business hours.

2. Summary of the Plan Process

As part of the Plan development process, public hearings were held on February 24 and March 24, 2015. The purpose of the public meetings was to obtain the views of citizens, public officials and agencies and other interested parties regarding the housing and community development needs of the jurisdiction and to review past performance. A final public hearing on the Plan has been scheduled for June 23, 2015 at 7PM 475 DeMott Lane in the Township Municipal Building. A resolution authorizing the submission of the 2015 Consolidated Plan and 2015 Action Plan has been scheduled to be adopted by the Township Council.

3. Available Funds

The Township's fiscal year 2015 entitlement is \$254,835. No program income is anticipated.

4. 2015 Action Plan

Based on a review of projects proposals submitted to the Mayor and Council, an Action Plan for the use of fiscal year 2015 CDBG funds has been prepared and is as follows:
