Dear Ms. Woodbury:

Parker E. Francis Memorial, Inc. is proposing to construct a 1,400 SF children's outdoor recreation space (i.e. playground) on the northeast side of the existing nursing facility building. The current nursing facility houses one resident per room and currently contains 120 beds - 60 of the beds are for skilled nursing/long term care and 60 are for short term care. A portion of the existing nursing facility will be modified internally to provide amenities to operate a licensed Child Day Care wing at the facility. The Child Day Care's primary purpose is to provide care of Parker's employees' children/grandchildren and promote intergenerational programming opportunities for the Parker at Somerset Elders. Accommodations for parent drop-off and pick-up will be made at the Facility's front entrance to the Main Lobby. No additional building or site development space is anticipated.

Stormwater runoff from the development site will be controlled by the existing underground detention basin and the extended stormwater detention basin. The water quality portion of runoff is controlled by detaining 10% of water quality storm in the basin for more than 12 hours and four (4) existing on-site pervious pavement sections placed in series with the extended detention basin.
