## Subordination Agreement

This Subordination Agreement is dated this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ executed and extended by the Township of Franklin, a New Jersey municipal corporation (SUBORDINATING PARTY).

WHEREAS, \_\_\_\_\_, (OWNERS) hold fee simple title to, and ownership of the SUBJECT PROPERTY, and is under contract to refinance the SUBJECT PROPERTY.

WHEREAS, the Mortgage requires that the above referenced loan be a first mortgage lien against the SUBJECT PROPERTY; and

WHEREAS, as an accomodation to the Owner , the SUBORDINATING PARTY, has agreed to execute and deliver, for recodation, the SUBORDINATION AGREEMENT so that the MORTGAGE will be made subordinate and inferior to the lien of the Mortgagee which is to be executed by the Owner in favor of Mortgagee, its successors and/or assigns, to secure the principal loan amount not to exceed \$ \_\_\_\_\_ which to be advanced by the mortgagee.

NOW, THEREFORE, the undersigned on behalf of the SUBORDINATING PARTY, does hereby represent, covenant, and agree as follows:

1. That the MORTGAGE dated \_\_\_\_\_, 20\_\_\_\_ and recorded \_\_\_\_\_, 20\_\_\_\_ in the Official Records Book \_\_\_\_\_; Pages \_\_\_\_\_ of the Public Records of the County of Somerset, New Jersey, and as described in the first paragraph of the preamble of the SUBORDINATION AGREEMENT, is owned and held by the SUBORDINATING

PARTY, and that the MORTGAGE has not been assigned, transferred or pledged to any person whomsoever, so that the SUBORDINATING PARTY has full right and authority to execute this SUBORDINATION AGREEMENT.

2. That the above-described MORTGAGE held by the SUBORDINATING PARTY are declared to be inferior and subordinate in lien right and dignity to only the Mortgage itself in the original principal loan amount and not to exceed \$ \_\_\_\_\_, just as though the Mortgage has been executed, delivered and recorded prior to the execution and recordation of the MORTGAGE held by the undersigned, SUBORDINATING PARTY.
3. Accordingly, the MORTGAGE held by the undersigned, SUBORDINATING PARTY, is now and shall be inferior and subordinate to the lien of the Mortgage which is to be executed by the Owner to the Mortgagee, its successors and/or assigns, and which shall be recorded in the Public Records of Somerset County, New Jersey concurrently, with and immediately prior to, the recordation of this SUBORDINATION AGREEMENT.
