Franklin Food Bank **Offers Help in Two New Ways**

The Franklin Food Bank is proud to announce the re-launch of our Client Choice program at our facility located at 224 Churchill Ave. Originally established in 2019, this market-style distribution model was suspended at the onset of the COVID-19 pandemic. This March, our staff and dedicated volunteers worked tirelessly to reset our main method of food distribution and re-opened our doors to allow township residents in need the opportunity to "shop" for the food and supplies that best fit their lifestyle.

Individuals and families apply to the program and receive a card with points, based on household size. Clients shop the market with their points, by appointment, up to two times per month. The market is set up just like a mini-grocery store, with a section for produce, dairy, frozen foods and non-perishables. Giving clients control to select the items they need most and enjoy allows the Franklin Food Bank to stay true to its mission since 1975: to serve those in need in an atmosphere of dignity and respect.

Given the current economic landscape, more and more neighbors are finding it difficult to make ends meet. For those who are having a hard time making their food budget last, short-term supplementary help is available, no questions asked. The Franklin Food Bank is hosting Community Distribution Days on

Voter Registration

You must be a citizen of the United States; you must be 18 years of age on or before the day of the election & you must be a resident of your present address for at least 30 days before the election. Voter Registration Forms can be printed from the Township's website: www.franklintwpnj.org and must be received by the Township Clerk's Office or the Somerset County Board of Elections 21 days prior to Election Day.

Voting by Mail-In Ballot

You may vote by Mail-In-Ballot for any election. You do not need a reason. You must apply for a mail-in ballot by completing a Mail-In Ballot Application. Application Forms can also be obtained from the Somerset County Clerk's Office and the Franklin Township's Clerk Office. Mail-In Ballots are to be mailed to the County Clerk's Office postmarked by Nov. 8, 2022 or placed in Drop Box at the Municipal Building by 8:00 p.m. on Nov. 8, 2022. The County Clerk cannot accept faxes or electronic copies, as an original signature is required. You may apply in person at the County Clerk's office up to 3:00 p.m. on the day before the election.

Early Voting

Early Voting takes place from Sunday, Oct. 29, 2022 through Sunday, Nov. 6, 2022 at the Community/Senior Center located at 505 DeMott Lane, Somerset, NJ. Polls are open from 10 a.m. to 8 p.m. on Monday through Saturday and from 10 a.m. to 6 p.m. on Sunday. Anyone in Somerset County may vote at this polling location during this time period.

Drop Box

There is a Drop Box for Mail-In Ballots for all Somerset County municipalities located in front of the Municipal Building. The box will open approximately a month before Election Day and will remain open until 8:00 p.m. on Nov. 8, 2022.



Advisory Do Not Plant Tree List.



Are you adding trees to your property this fall or in the spring? Do you want to know which trees are best suited to our climate and area? Do you also want to stay away from trees that are vulnerable to disease, invasive, or overplanted? The Shade Tree Commission has produced an advisory Do Not Plant Tree List to raise awareness of trees that should not be planted around our Township. Many of the trees on the list are considered invasive species due to their aggressive growing habits that crowd out native species and negatively impact local biodiversity. The list also includes several shade trees that have been added because they attract insect pests, diseases or have poor growth habits that make them difficult or costly to manage. We are constantly working with regional arborists and urban forestry experts to update the list, so please check our website for the latest list before you purchase or plant any new trees (https://www.franklintwpnj.org/shadetree). Franklin Township Initiates Adopt-A-Drain!

In cooperation with Township Council and the Franklin Township Department of Public Works, Franklin Township's Environmental Commission has recently launched the Adopt-A-Drain program. The Adopt-A-Drain program is a national program (out of Hamline University in Minnesota) where town members are invited to act as caretakers for their local storm drains.

Now you can be part of our community efforts to protect Franklin residents, properties and streets by volunteering to Adopt-A-Drain! It's easy - just log in to https://nj.adopt-a-drain.org/ to learn more.

How to Adopt a Storm Drain:

Franklin has 7,473 stormwater drains. All you have to do is volunteer 15 minutes, twice a month (or other regular interval that you choose as deemed necessary), for cleaner waterways and a healthier community. Storm drains flow directly to our streams, wetlands, and the Millstone and Raritan Rivers; acting as a conduit for trash and organic pollutants. Adopt-A-Drain asks residents to adopt a storm drain in their neighborhood and keep it clear of leaves, trash, and other debris to reduce water pollution.



Sign up on line to Adopt-A-Drain in your neighborhood!

- Keep your drain clear: sweep and/or rake leaves, trash, and other debris off the drain surface year-round.
- Adopt A Drain provides safety tips, will send you a lawn sign to put in your yard and lets you see what contribution you are making to our life here in Franklin, where blocked storm drains and contaminated storm waters are becoming more and more of a threat.
- Track your impact: keep an estimated total of the debris you collect and enter it into your online account so we can gauge the cumulate results of our work.
- Lead by example: let friends and neighbors know about your commitment and, if they ask, tell them about small things they can do at home to prevent water pollution.

Franklin Township Librarians are on the go!

Jellyfish caps and pirate hats were popping up at the township parks as librarians visited the summer camps run by the Franklin Recreation Department. Each weekly visit included stories and songs themed to the 2022 Summer Reading Program entitled "Oceans of Possibilities".



Shark, whale and squid puppets traveled with the librarians to 3 camps and several outdoor events throughout the summer, such as Franklin Days' July 4th Fireworks festivities and National Night Out on August 2. Outreach librarians also "dove into some great books" with the families that attended the Great Big Book Fair held on the high school field on July 16.

In addition to sharing stories at the camps, children had the opportunity to get up and dance with the librarians. Play-based literacy activities allow children to have fun while learning vocabulary and narrative skills. By interacting with the librarians' stories, children maintained skills acquired over the school year to help avoid the "summer slide". Our Franklin students were better prepared for the reopening of school by attending a library program.

The outreach librarians "reeled in" the children by sharing stories and interesting trivia facts (Did you know? Sharks are truly silent predators because they have no organs for producing sound!). In turn, the children share their knowledge about sea life, protecting our ocean and our water system. Our librarians continue to offer 30 minute outreach storytimes with the goal of developing lifelong readers and learners and will be visiting local public and private schools throughout the school year.

In addition to our outreach, children's programs are held throughout the year at the DeMott Lane Branch, Franklin Park Branch and the Lewis Street Branch located in the new Youth Center. Franklin First Aid Squad Celebrating 75th Anniversary!

In 1947, a few people in the East Millstone area agreed that they needed an ambulance squad to transport the sick and injured to the hospital. On June 10, 1947, the East Millstone First Aid Squad was incorporated. Their mission was to provide FREE transport to those in need. Their first ambulance



was a Cadillac ambulance purchased for \$2,000.00. That was a time when they had a swoop and scoop attitude to get the injured to the hospital fast. Very little medical training was needed. In 1969, the first EMT-A program was started and in 1975 the American Medical Association acknowledged emergency medicine as a specialty and developed more advanced training courses. Now, between the EMTs (BLS) and the Paramedics (ALS), the emergency room is brought to the patient wherever they are. We still provide 100% FREE service to the members of Franklin Township.

While the training has changed over the years, the need for more volunteers to help answer 911 calls in our community has not changed.

Our members, all of whom deeply feel the call to help others, come from diverse careers, backgrounds and cultures, and range in age from 16 to retirees.

We have served our friends and neighbors throughout pandemics, protests, hurricanes, community events and regular daily life when they find themselves in the greatest need.



Franklin Seeks Your Voice for Better Community Health



Not only does this survey give us the picture of health for those that live in this community each day, it is the first step in creating positive change throughout Franklin regardless of neighborhood, race, economic status, or any number factors that may hinder access to health resources," said Project Leaders Saffie Kallon and Tara Kenyon.

Over the next several months, the Township will be doing surveys, meeting with community leaders, and speaking with residents like you to assess your access to health and wellness resources within the community. 

Zufall Health Offers Services and a Medical Home to FTPS Students

Zufall Health has partnered with the Franklin Township Board of Education to supply the students of the district with medical services on the campus of Hillcrest School. This summer, those services were provided via a mobile van in anticipation of a more permanent home at that campus. Student families were able to make appointments and the sense of welcome for those new patients was enhanced by give aways and gift cards. Over the next few months the portable classrooms at Hillcrest School, previously utilized by the district before the One Less Move Referendum, will be refurbished to provide a school based health center for FTPS students.

"We are very excited to partner with Zufall Health to provide an opportunity for our students to receive quality health care at a convenient location for their families," said FTPS Superintendent Dr. John Ravally. The health center was made possible by a grant from the Health Resources and Services Administration with the purpose of providing health care access to students with the greatest need.

"We will provide a variety of services for FTPS students including physicals, well visits, and immunizations," explained Ms. Krishna Patel, RDH MPH, Zufall Health Director of Community-Based Clinical Services, "but for those families without a primary physician, we can become a child's medical home." Providing health care opportunities for our students is important for not just their physical well-being but academically as well," said Dr. Brenda Sofield, FTPS Director of Pupil Personnel Services, "illness

or lack of proper vaccinations can cause absences which disrupt student learning."

"We look forward to providing services to the students of Franklin Township Public Schools and encourage those who do not have students in the district or other family members to call our office to discuss the services we might be able to provide at another location," said Ms. Frances Palm, MPA, Chief Operating Officer of Zufall Health. "Those families with insurance are welcome to utilize our services, and those without coverage will be charged on a sliding fee scale," said Ms. Palm.

What does the future of this opportunity look like? What hours and services will they provide? Dr. Ravally explains, "This endeavor is a work in progress and more information will be forthcoming, but we are grateful to the Board of Education's approval of the grant application, the Zufall Health organization and the leadership of Franklin Township for their support as well." Updated information on the Hillcrest School location will be provided to district families as it becomes available.

Summer Programs Provide Continuity, Fun and a Chance to Explore One's Leadership Style

Franklin Township Public School facilities were home to a variety of summer programs during the months of July and August. From traditional programs such as the Extended School Year (ESY) for students with special needs and English Language Learners to academic recovery programs funded by Federal Grants, FTPS hosted over 15 programs at four locations in July and August. "The purpose of ESY services is to assist students in maintaining skills at risk of regression or for students with severe disabilities to attain the critical skills or self-sufficiency goals essential to the student's continued progress," explained Ms. Holly Gamble, Supervisor of Pupil Personnel Services for Grades 6-12. Ms. Gamble continued,

"Since its inception ESY has been really important, but since the pandemic it has been even more necessary. Students were out of school learning remotely, which was particularly difficult for Special Needs students. ESY is a time to make up for academic learning loss and build back vital social/emotional goals." An important addition to the Extended School Year is a week of Summer Olympics where students in the program participate alongside general education students in activities such as bowling, track & field, Zumba and e-games.

"Summer programs continue to provide students the academic support needed to succeed while fostering a love for learning thorough a small group, hand-on approach. Our end goal is to allow students the opportunity to continue to grow while having fun in the summer," says Ms. Ana Washington, Director of Research, Planning, Accountability and Assessment. Some of the programs featured a math, language arts and elective while others were more project based. In the Book Club/Mural Project a small group of students read and discussed a book and then designed and created a mural for their school based on the book's themes. In the Leadership Academy students in the seventh and eighth grade completed a service project while exploring their leadership styles.

Another opportunity for emerging leaders was offered by the Recreation Department of Franklin Township this past summer. Twelve students in grades six to eight met daily at Future Leader of Franklin Camp which was held at the Board of Education Administrative Campus. (BAC). "The focus of the camp is to provide youth with a balance of fun summer activities while integrating leadership and teambuilding elements to build their confidence and professional competencies," said Windy White, Deputy Director Franklin Township Parks & Recreation. Students discussed leadership styles with guest speakers such as Tony Taveras from the Franklin Youth Center, who stressed the importance of having a shared goal and listening to those you hope to lead. "In a conversation with members of your team, don't think ahead to the next thing you are going to say, but listen to their feedback," said Mr. Taveras. He then asked for the students' feedback on activities that the Youth Center could provide. "Campers continue to express their great appreciation for our staff," said Ms. White, "We are fortunate to have a dedicated and diverse team who make the leadership camp experience interesting and fun every day."

Franklin Township Public Schools will begin the new school year with two supervisors dedicated to the counseling needs of students in grades K-12. Mr. Ammon Barksdale is currently the supervisor for our Franklin High School students. Mr. Barksdale has been with the district for 23 years and has served in a variety of roles including teacher, school counselor, vice principal and interim principal. He transitioned back to the school counseling area last school year when he was appointed supervisor at FHS. He enjoys working with his team of counselors who he describes as enthusiastic about their craft with an energy that makes them relatable to the student body. The high school counseling department primarily assists students in planning for their future. They provide information on college and career choices; supply support in the social, emotional development of their students; assist in refining student communication skills and celebrate the accomplishments of their students with the school community. Mr. Barksdale believes in "meeting students where they are." He and his team will focus their energy this year on "Fostering an environment where students feel validated and safe to express themselves and grow."

Providing counseling support to younger students as they grow now has a broader meaning to the new Supervisor of School Counseling for grades K-8, Ms. Quiyon N. Peters. Ms. Peters had served the students of the district, at the middle school level, for eight years as a school counselor, College and Career Readiness and Family Engagement Coordinator as well as a Harassment, Intimidation and Bullying Specialist. 


Mr. Armando J. Quiroz
