CALL TO ORDER IN ACCORDANCE WITH THE OPEN PUBLIC MEETINGS ACT (N.J.S.A. 10:4-6)

Chairman Bob Puskas called the meeting to order at 8:05pm.

PUBLIC COMMENT

As no members of the public were present, a Public Comment session was not held.

APPROVAL OF MEETING MINUTES - APRIL 4, 2024

Cathy Blumig made a motion to approve the meeting minutes of April 4th, which was seconded by Rik Johnson. All agreed, and the motion carried.

NEW BUSINESS

Updated Soil Protection Standards

Tara Kenyon updated the Committee on the most recent version of the Soil Protection Standards prepared by the State Agriculture Development Committee (SADC). Based on comments received from municipalities, counties, non-profit entities, and agriculture-based organizations across the State on the last version of the Soil Protection Standards, the following changes were made:

1. The maximum soil disturbance allowance (12% or 4 acres, whichever is greater) will no longer apply to farms preserved prior to the anticipated adoption of these rules (October 1, 2024). Only new disturbance will be counted towards farms that are grandfathered into these rules.

- 2. The waiver process has been streamlined. Farmers are no longer required to complete the notification process this responsibility has been shifted to municipalities. Most importantly, farmers will not have to prove that there is "no feasible alternative", which typically includes the professional work of a licensed engineer.
- 3. In the previous version, "ball and burlap" practices were not addressed. The most recent iteration refers to this agricultural practice as "dug nursery stock" and has added it to the list of exempt soil disturbances.

The comment period ends on September 13th. The Franklin AAC has no additional comments to provide to the SADC.

2024-2025 Deer Management Program

Tara updated the Committee that the application period for the Franklin Township Deer Management Program has ended, and the lottery was held. The Clerk's Office Staff is working on preparing the permit packages and mailing them out to hunters. The hunting season begins on Saturday, September 14th and ends on Saturday, February 8th.

90-Day Notification Letter to SADC for Municipal Planning Incentive Grant

Tara has prepared the required 90-Day Notification Letter demonstrating the Township's intent to apply for the annual Municipal Planning Incentive Grant to the SADC and Somerset County Agriculture Development Board and will submit by the deadline of September15th. The complete Annual Application is due on December 15th.

Other Business

Cathy Blumig added that the annual "Ag in Action" is being held on Saturday, September 7th from 10am – 2pm at the Carnevale Farm in Hillsborough. Later that same day (7pm) at the same place (Carnevale Farm), the Somerset County Board of Agriculture is hosting the Annual Thomas Everett Memorial Scholarship Dinner.
