- 1. Call to order Meeting was called to order by Chairman Jones in accordance with the Sunshine Law at 7:02pm Members present indicated above by (P).
- 2. Minutes: In the review of the May and June Minutes, Schmidt commented that in the May meeting, the committee voted to recommend holding off bonding as long as possible. In retrospect, if we had known at that time the actual OSTF dollar amount the Council was going to approve for Middlebush Park, which was a lot more than the OSAC had been told, he would have made the case that to spend that amount, without bonding, could jeopardize our ability to purchase properties currently under review. Therefore he said he likely would have voted to bond at that time.

- Financial Report. Financial report dated was reviewed. The balance in the OSTF is \$10,130,011.44. Williams moved, Puskas seconded motion to except report. Motion Passes
- 4. Open first opening to public: Connell Moved, Williams seconded motion to open first open session.

5. New Business

a. Negri Nepoti Mowing: Varacalli reported a more aggressive Mowing schedule to manage invasive species including Canada thistle and Mug wart. Williams was concerned that Cutting to early affects grasses and bird habitats., Varacalli countered that waiting too long will exasperate the growing concerns about invasive species

A subcommittee was formed to review and advise on best mowing plan. (Herrling-Williams-Connolly-Puskas). Chairman Jones requested a report be given to committee when complete

 b. Mercer County. Varacalli presented news article regarding Mercer county voting on dedicating a specific amount of open Space tax to maintenance of park land. c. Smith Road Residents Encroachment on open space land. This neighborhood fought heavily against using the rail bed as a trail several years ago, so that plan was abolished. At the time it was noticed several encroachments of private property onto the open space land. A recent review of the trail bed has revealed additional encroachments. One by-passing the rail and entering Galdi farm. A survey will be taken and notices will be sent out to residences to resolve issue.

- Magellan Way. Residents are dumping grass and encroaching On Catalpa open space property. This condition will be reviewed
- e. Quarry in Kingston. Part of the Kingston quarry may qualify for green acres funds
- f. Dunn and Gunther Varacalli reported agreement may be able to be amended to remove house from ROSI

g. Mowing. The issue of proper mowing seems to be a growing problem. It was suggested that a group be trained on what proper mowing procedures should be. The sentiment of the committee was this is a good idea, but mowing is filler work and

We are lucky to get it done at all, no less correctly. The suggestion will be discussed to see what cooperation we get.

Mowing. It was asked to review all current mowing instructions for trails to make sure public works is properly informed on what needs to be done.

- h. Puskas reported bikes being seen on Negri Nepoti, which is not allowed. It was assumed that people are coming off Six Mile Run and Skillman road and may not be aware they are on a new property.
- Jones/Varacalli requested Connell (secretary) to return minutes inside the monthly cycle of meetings to assure proper follow up on matters discussed during meetings.

6. Old Business.

- a. Middlebush Park.
 - -It was reported that Walking Trail work has begun
 - -The first artificial turf field by parking lot is complete. They just completed seeding area. Vornlocker made note that even the footprint of the second turf field was seeded to prevent erosion and safety problems. It should also be noted on this Tuesday it rained like cats and dogs. This was a perfect stress test for the drainage plan of the park.
- b. Summer Help. The summer help was very productive.
 They rebuilt boardwalks, Put up signs, worked on invasive species, and reworked trails. Several damaged by Hurricane Irene. They worked for approximately 8 weeks.
- c. Nature Walks
