

**Chain of Command for Tree Management:** The Public Works Manager, in cooperation with the Township Administrative Secretary, the Tree Foreman and the Shade Tree Commission, is responsible for overseeing the management of trees in the Township.

Complaints about potentially hazardous trees: Can be received by phone call, email or website request... Adminstrative secretaries enter work order into system... work order reviewed by Public Works Manager... tree maintenance or complaint request sent to Tree Foreman to inspect site... work scheduled.

**Organizational Chart?** Nothing formal. See attached Flow Chart.

Do you have a mission statement? What is it? Do you have a Master Plan? Any annual reports?

**Mission Statement:** The Franklin Township Shade Tree Commission promotes the conservation and stewardship of trees throughout the Township by advising township officials regarding planting, care and maintenance of trees on townshipowned lands. The Commission will assist Franklin Township residents by increasing awareness of the benefits of arboriculture and providing advice and information regarding the selection, planting and care of trees. **Master Plans**: Our Master Plan was originally written in 2003 and was revised, but never completed for the period 2008-2013. On advice of the Community Forester, Alex McCarthy, we are starting over on a new Community Forestry Management Plan.

During the listening session we will conduct a brainstorming activity to gather your ideas about the needs of the Township of Franklin. If every tree group member suggests one or two projects/activities that fall into these broad categories, we would have plenty of work to propose for the first 5-year plan. Upon completion of the brainstorming activity, the tree group members will be asked to rank the ideas in order of their preference. After ranking, the ideas will form the basis of a schedule of activity for the plan. These activities will be tied to state funding through the CSIP grant program.
