# REDEVELOPMENT AGENCY OF FRANKLIN TOWNSHIP SOMERSET COUNTY, NEW JERSEY Minutes of Meeting January 27, 2014

The meeting of the Redevelopment Agency of Franklin Township was held at 475 DeMott Lane, Somerset, NJ and was called to order at 7:34 p.m. by Mark Healey. The Sunshine Law was read and the roll was taken.

#### **ELECTION OF OFFICERS**

Mr. Mettler nominated Mr. Gianotto for Chairman, seconded by Mr. Sanders and unanimously approved by a roll call vote. (Mr. Wright did not vote as he was not yet present) Mr. Mettler nominated Ms. Francois for Vice Chairwoman, seconded by Mr. Sanders and unanimously approved by a roll call vote (Mr. Wright did not vote as he was not yet present)

### **RESOLUTION 01-2014 - ELECTION OF OFFICERS**

Mr. Mettler made a motion to adopt Resolution 01-2014 which appoints Mr. Gianotto as Chairman and Ms. Francois as Vice Chairwoman. The motion was seconded by Mr. Sanders and unanimously approved by a roll call vote. (Mr. Wright did not vote as he was not yet present)

### **RESOLUTION 02-2014 - AWARD OF LEGAL SERVICES CONTRACT**

Mr. Mettler made a motion to adopt Resolution 02-2014 which awards a contract for legal services to McManimon, Scotland & Baumann, LLC. The motion was seconded by Mr. Reynolds and unanimously approved by a roll call vote. (Mr. Wright did not vote as he was not yet present)

### **APPROVAL OF THE MINUTES**

The Regular Meeting minutes of December 16, 2013 were approved as submitted, with a motion made by Mr. Sanders, seconded by Mr. Reynolds and unanimously approved by a roll call vote.

#### RPM – UPDATE

Mr. Healey briefly discussed the update as provided in the 1/24/14 memorandum from Brendan McBride of RPM. Ms. London added a synopsis of the Buist negotiations and informed the Board that she expects further information for the Agency at their February meeting.

## **LEEWOOD UPDATE**

Mr. Healey briefly discussed the update as provided in the 1/23/14 email from Michael Fink of Leewood. Ms. London added a synopsis of her 1/22/14 memo regarding the negotiations for 5 Irving Street and asked that the Agency allow her to continue with the negotiations. The Agency instructed Ms. London to continue with the negotiations and to keep the Agency informed.

### **REDEV UPDATE**

Charles Avery of Redev was in attendance and he summarized his 1/22/14 update email and thanked both the Agency and the Township for their assistance.

### **MR. REYNOLDS RESIGNATION**

Mr. Reynolds notified the Agency that he was resigning from the Agency due to personal commitments.

### PROPERTIES IN THE RPM'S REDEVELOPENT AREA NOT TO BE DEVELOPED BY RPM

The Agency directed Mr. Healey to contact RPM to determine if there are any properties that they do not intend to develop within their redevelopment area and if so would they will be willing to remove those properties from the redevelopment area.
