REDEVOLPER PRESENTATION - FRANKLIN-JULIETTE, LLC

Mr. Peter Lanfrit, Esq. representing Franklin-Juliette LLC gave a presentation explaining his client's proposed project which included the following:

- 1) Requesting that his client be designated the redeveloper for 607 Somerset Street (Block 164, Lots 1-26) for the construction of a Wawa (convenience store and gas filling pumps)
- 2) Requested that the Agency endorse the rezoning of the property to allow for the Wawa
- 3) The development is a joint venture between Arc Trust and a Rich Dreher company.
- 4) The project is well financed with 100 million available for development
- 5) Mr. Dreher has a proven track record in Franklin (Rite Aid, Bank and Dunkin Donuts on Elizabeth Avenue)

Mr. Healey recommended that the developer submit \$5,000 for escrow and the developer agreed to do so.

After the agency discussed the project Mr. Mettler made a motion to authorize the preparation of redevelopment agreement with Franklin-Juliette and a Resolution designating Franklin-Juliette LLC as the redeveloper of 607 Somerset Street. The motion was seconded by Mr. Agudosi and unanimously approved by a roll call vote. Mr. Mettler then amended his motion to indicate that the redevelopment agreement and Resolution should have Franklin-Juliette LLC as the conditional developer, said motion was seconded by Mr. Agudosi and unanimously approved by a roll call vote.
